SUBJECT INTENT STATEMENT

The history curriculum is designed to allow pupil to develop a body of knowledge about Britain's past and the wider world to allow them to make more sense of it.

In generating our history curriculum, ensuring we meet the demands of the national curriculum, we have aimed to create a curriculum which has balanced disciplinary and substantive knowledge, pupils are able to make sense of the information they have acquired.

Disciplinary knowledge is developed to enable pupils to understand how historians study the past, with progression of second order concepts of cause and consequence, change and continuity, significance, and the use of historical evidence and interpretations.

Substantive knowledge is developed by focusing on topic knowledge, enabling pupils to understand the event and societies they are taught, chronological knowledge to develop a mental timeline, coherent narratives of the past, and an understanding of agreed historical markers, and substantive concepts threaded throughout the curriculum.

At the heart of curriculum, we emphasise the learner's ability to focus on historical enquiry, engage with a wide range of written and visual sources to develop their ability to reach sustained judgements and fully understand the craft of an historian.

We seek to broaden student learning through the diverse lens of different sections of society. We emphasise the range of events and experiences that have ultimately shaped the twenty first century.
